

Proceedings of the Workshop on Formation of City Managers' Association, Orissa (CMAO) held on 15th April 2002 at Swosti Plaza Hotel, Bhubaneswar

On 15th of April 2002 a state level workshop on formation of "City Managers' Association, Orissa (CMAO)" was jointly organised by Government of Orissa, Indo-USAID Financial Institutions Reform and Expansion (FIRE) project, National Institute of Urban Affairs, New Delhi and United States - Asia Environmental Partnership (US-AEP) with International City/ County Management Association (ICMA). In this workshop officers of various urban local bodies, development authority and Government of Orissa participated and expressed their deep concern in the prevailing urban scenario in the state, national and globally.

During workshop the participants expressed that there is a need of city managers associations in the state. They expressed the CMA of Orissa will serve as a clearinghouse for the collection, analysis, and dissemination of local government information and will facilitate formulation of public policy. It will also provide technical assistance on a broad range of management issues to local governments in the state. During the day the following Sub resolution were approved: -
